- 2. A detailed description of the subject of the order:
 - Three sets of test sheets joined by explosive cladding method, as follows:
 - a) Grades: Aluminum A1050 + nickel alloy 201 (2.4068).
 - b) The size of a single sample after removal of technological margin, i.e. with a continuous joint between the joined sheets: (1 + 1) x 150 x 300 mm 3 pcs.
 - c) Execution of each of the plates with separate cladding parameters; different detonation speed while maintaining a constant distance between the clad plate and the base plate (parallel system).
- 3. For the implementation of the order, the Orderer will provide the Contractor with **as in point 2**.
- 4. The Orderer does not allow the possibility of placing partial offers.
- 5. The Orderer does not allow the possibility of subcontracting a part or the whole of the order.
