 - two stainless steel wire cloth mesh count 230, SD 75x36 (or similar), 45° high tension (for BSF and back contact)
 - three stainless steel wire cloth stretching into a frame,
 - three coating of a photopolymer emulsion 30 µm into the screen,
 - three developed and expose the film, 25-50.000 dpi,
 - three screen imaging and development from the description of diameters,
 - packing and freight to Poland.




